Introduction

This document

This Data Privacy Statement has been produced by the Bristol Multi Faith Forum ('BMFF' or 'we'). It has been produced in response to the General Data Protections Regulations ('GDPR') which came into effect on 25 May 2018.

We hold information about some people ('data subjects' in the language of GDPR, or 'you'), and this document tells you what we think you need to know about the information we hold about you.

You can find a list of the abbreviations used in this document in the appendix, 'Abbreviations used in this document'.

Changes

We may change this Data Privacy Statement at any time; this may be done to clarify what has been said, to address details which were not previously covered, to respond to changes in the legislation or in interpretation of the legislation, or for some other reason.

The BMFF Data Privacy Statement is contained in the most recent published version of this document and is available on the BMFF web site, details of which can be found in the appendix, 'Contact details'. The version number is given on the front page, and the version date is given at the foot of every page.

Updates to this policy are effective immediately; notification of a new version will be provided on the web site and may also be given in other ways. We will continue to make old versions of this document available for two years, to enable you to compare the changes which have been made.

About us

The BMFF seeks to:

- give a voice to people of faith, faith communities and faith based organisations;
- serve as a forum for faith communities to enter into dialogue with each other

- and with relevant organs of the statutory, private and voluntary sectors;
- develop and nurture leadership in the faith communities, in partnership with those communities; and
- be a platform for focus on commonalities and shared objectives amongst the faiths.

The BMFF primarily works to assist in the building of strong communities by developing healthy relationships between all those involved in the faith communities, and between them and the wider organisations, systems and structures of the city.

The Steering Group, elected at the AGM each year, decides policy and makes strategic decisions for BMFF, including decisions about data storage and processing. This means that, in the language of GDPR, the Steering Group is the Data Controller ('DC').

All members of the Steering Group are responsible for ensuring that we operate both morally and legally (which includes complying with the GDPR), but one member of the Steering Group will take a special interest in and responsibility for data protection (one aspect of which is data privacy) and will handle the day to day data protection activities. In the language of the GDPR, this person is the Data Protection Officer ('DPO'). The DPO reports to the Steering Group and is the initial point of contact for issues related to data protection, but the Chair of the Steering Group can be the point of contact if the DPO is unavailable or not appropriate for some reason. Names and contact details for the Chair and the DPO can be found on the web site.

Personal Data

Collection

When personal data is collected from individuals, we will inform them why their data is being collected and how it will be used; we will also provide them with access to our Data Privacy Statement, Data Register and full Data Protection Policy.

When personal data is collected at an event through the use of a sign-up sheet, we will provide alongside the sign-up sheet the text of our Data Protection Summary (see below), which will also inform people of more secure ways they can provide their information.

The sign-up sheet will be stored securely and saved in the appropriate data store at the earliest opportunity. Once the data has been saved and backed up, the original sign-up sheet will be destroyed.

One piece of personal data which we collect is 'Religion': this is necessary for our monitoring purposes, as we are required to engage with all the faith communities in Bristol. This data collection is permitted under Article 9(2)(e) of the GDPR, because we only collect this information when it has been "manifestly made public by the data subject".
